

# ISSA List License Agreement

Members

1. Subject to the user's full and complete compliance with the terms and conditions outlined below, ISSA hereby grants the user a nonexclusive, nontransferable, nonassignable, terminable, limited license with regards to the requested ISSA list(s).
2. The user represents and warrants that s/he shall use the requested list(s) only for the specific purpose agreed to by the user and ISSA. The user agrees that s/he will not disclose, transfer, duplicate, reproduce, or retain any portion of the list(s) in any form whatsoever and will not enter any information contained in the list(s), in whole or in part, into an electronic database, except for the specific purpose of creating a mailing list for his/her exclusive use.
3. The user agrees that s/he will not use the requested membership list(s) for any ISSA campaign activity, either on his/her own behalf or on behalf of any third party candidate for ISSA office. The user further agrees that the requested membership list(s) may not be used by either the user or any third party as a campaign tool or resource and may not be used in furtherance of any political activity.
4. The user may not, under any circumstances or for any purpose, distribute or otherwise provide the requested list(s) to any third party unless express prior consent is provided by ISSA in a separate writing. Providing the requested list(s) to a third party in violation of this license may result in immediate suspension of the user's membership in ISSA.
5. The user agrees to reimburse ISSA for all costs which ISSA may incur in enjoining unauthorized parties from using the list(s) if the unauthorized party gained access to the list(s) through the actions of the user subject to this license or any of the user's agents or employees.
6. Except for the limited license granted to the user in accordance with the terms and conditions outlined below, nothing in this license shall grant to the user any ownership or right to the list(s). ISSA shall maintain all intellectual property rights to the list(s).
7. ISSA reserves the right to monitor the use of the list(s) and all information contained within.
8. The user agrees that, upon request, s/he will furnish ISSA with complete details as to the usage of the licensed list(s).
9. Failure to comply with the specific terms and conditions outlined above, including use of the list(s) for a purpose that is inconsistent with this license agreement, will result in immediate termination of the license and may render the company, organization, or individual ineligible to request, order, or use an ISSA list in the future, at ISSA's sole discretion.
10. This license may be terminated by ISSA for any or no reason by providing written notice of termination to the user.
